Government Bills

Passage

Mr. Bellemare, Minister of Justice, moved the passage of Bill 21, An Act to amend the Civil Code and the Code of Civil Procedure as regards the determination of child support payments.

After debate thereon, the motion was carried and, accordingly, Bill 21 was passed.

Information on the Proceedings of the Assembly

Mrs. Leblanc, Second Vice-President, informed the Assembly that on Wednesday, 21 April 2004, during Business Standing in the Name of Members in Opposition, a debate will be held on the motion by Mr. Dumont (Rivière-du-Loup). This motion reads as follows:

THAT the National Assembly demand that the Government appoint a commission of public inquiry on the quality of life of persons living in home care centres in Québec, whose mandate would be to break the law of silence prevailing in the network and to find long-term solutions which focus on the dignity and respect of our seniors.

ORDERS OF THE DAY

Government Motions

The Assembly held the debate on the motions moved at the sitting of 1 April 2004 by Mrs. Gagnon-Tremblay, Minister of International Relations. These motions read as follows:

20 April 2004

THAT, pursuant to section 22.3 of the *Act respecting the Ministère des Relations internationales*, the National Assembly examine and approve, within the delay stipulated in the Act, the Convention on the Protection of Children and Cooperation in Respect of Intercountry Adoption.

THAT, pursuant to section 22.3 of the *Act respecting the Ministère des Relations internationales*, the National Assembly examine and approve, within the delay stipulated in the Act, the Optional Protocol to the Convention on the Rights of the Child, On the Sale of Children, Child Prostitution and Child Pornography.

THAT, pursuant to section 22.3 of the *Act respecting the Ministère des Relations internationales*, the National Assembly examine and approve, within the delay stipulated in the Act, the agreement on social security between the Government of Québec and the Government of the French Republic.

THAT, pursuant to section 22.3 of the *Act respecting the Ministère des Relations internationales*, the National Assembly examine and approve, within the delay stipulated in the Act, the amendment to the protocol of agreement between the Government of Québec and the Government of the French Republic relating to the social protection of pupils and students and participants in the cooperation held on 19 December 1998.

By leave of the Assembly, pursuant to section 22.3 of the *Act respecting the Ministère des Relations internationales*, it was agreed that the debate shall be held on the motions as a whole and shall last no more than one hour. Mrs. Leblanc, Second Vice-President, thus announced the allocation of speaking time for this debate: twenty-five minutes shall be set aside for the group forming the Government; ten minutes shall be set aside for the independent Members; within this framework, any time not used by a parliamentary group may be added to that of the other group, while any time not used by the independent Members shall be redistributed equally amongst the two parliamentary groups, and individual addresses shall not be limited.

And debate arising;

By leave of the Assembly to set aside Standing Order 20, the proceedings continued beyond 6.00 o'clock p.m.

20 April 2004

The debate being concluded, these motions were carried. Accordingly, the four international commitments were examined and approved.

Debates Upon Adjournment

The Assembly held three debates upon adjournment:

- the first, on a question by Mr. Boisclair (Gouin) to Mrs. Beauchamp, Minister of Culture and Communications, about the funding of Télé-Québec;
- the second, on a question by Mr. Jutras (Drummond) to Mr. Marcoux, Minister of Transport, about the funding of road work for the 2004-2005 fiscal year;
- the third, on a question by Mr. Bédard (Chicoutimi) to Mr. Chagnon, Minister of Public Security, about the role played by mediator Jean Bazin in the Kanesatake matter.

At 6.42 o'clock p.m., Mr. Gendron, Third Vice-President, adjourned the Assembly until Wednesday, 21 April 2004, at 10.00 o'clock a.m.
